1. What works well for different community outreach approaches?


E.g. Compensate community members through nonprofit partners; translation; support existing events

The US is polarizing faster than most democracies




Only 20% of Americans trust the government to do what's right

Decreases in cross-class relationships are linked to fewer acts of kindness, gratitude, and generosity

33% of Americans believe most people can be trust



The social fabric of our communities is deteriorating




58% of Americans report feeling lonely some or all the time

We're experiencing an all-time low in social and civic group participation

Americans reporting **NO Close Confidants** increased by three-fold between 1990 to 2010



We're reckoning with a long history of racism & oppression



81% of major metro
areas were more racially
segregated in 2019 than they were in
1990

Hate crimes increased by 25% from 2010 to 2020



Parks are natural containers for organizing



working on a shared goal is one of the most effective means of building social capital across divides

Community engagement around park improvements has been shown to organize communities against the tides of gentrification



Parks are powerful and effective social infrastructure



Volunteering on environmental issues is proven to increase engagement in civic actions like attending town halls

Regular park users are shown to have 66% more social ties than those who don't regularly visit parks

Park investments have also been shown to boost trust in local government by 19%

Social Contact Theory

Consistent, face-to-face interaction between members who represent two or more different social groups (such as racial, ethnic, socioeconomic, religious, linguistic, or national groups)
